

## **Conditions of Entry in to the “Rider Tips” competition**

By entering this competition, you (the **entrant**) accept these terms and conditions.

1. This competition starts 21st June 2010 and ends 27th June 2011. Entries will only be accepted that are received between these dates and times.
2. You are only eligible to enter the competition if you are a permanent resident of Victoria aged 18 years and over who holds a valid Victorian motorcycle learner’s permit or licence and are not an employee, or related to an employee, of the TAC or one of its agents connected with this competition (Entrant).
3. To enter, entrants must submit a Rider’s Tip online which details a safety tip for motorcycle riders (Rider’s Tip).
4. An expert panel as chosen by the TAC, will review the Rider’s Tips and select one entry for the Prize. Chance plays no part in determining the winner.
5. Multiple entries are permitted. The TAC will not accept responsibility for late, lost, incomplete or misdirected entries. Submitted entries become the property of the TAC.
6. The Prize draws will take place on 11th October 2010, 10 January 2011, 11th April 2011, 27th June 2011 at 60 Brougham Street, Geelong, Victoria.
7. The winner of each draw will receive a pair of motorcycle protective gloves.
8. The Total Prize pool for all prizes in this competition is valued at \$879.80.
9. The winner of the each Prize Category will be notified by email and published on the TAC’s website: [www.spokes.com.au](http://www.spokes.com.au) at a future date.
10. No prize or part of a prize is exchangeable or redeemable for cash.

In submitting an entry you consent to the TAC providing your name and date of birth detailed on your entry form to VicRoads (or the equivalent regulator in any Australian state or territory), so VicRoads can verify your age and driving history for the purpose of confirming to the TAC that you are eligible to enter this competition.
